CALDWELL COUNTY COMMISSION MEETING

1. CALL TO ORDER

Commissioner Akey called the meeting to order at 8:30 a.m.

4. APPROVAL OF AGENDA/MINUTES

Commissioners opened bids for mowing the courthouse and Little Otter Creek property. The following bids were received: Milligan Outdoor Works \$100 weekly for courthouse/\$150 weekly with LOC; Purcell Lawn Care \$200 per mowing; Marts Mowing Service - \$180 weekly for the courthouse and \$65 for LOC.

Commissioner Akey moved to accept the bid from Milligan Outdoor Works. Commissioner Hibler seconded the motion. A roll call vote was taken, Commissioner Akey-yes; Commissioner Hibler-yes. The motion passed.

Mark Merrill with Emergency Management/Planning & Zoning who reported that grant reimbursements for \$57,900 for the generator and \$16,502.88 for storm sirens were received.

Raymond McElwee met with commissioners to discuss brush that was cut on his property by the county.

Commissioners called Terry Rumery to discuss the Economic Development for the county.

Beth Larkins, Collector/Treasurer met with commissioners to discuss properties for the 2024 tax sale. Brady Kopek, Prosecuting Attorney joined the discussion about a cemetery in Polo being put on the tax sale.

Sheriff Mitch Allen met with commissioners to get a signature of approval on a letter to terminate services of Advanced Correctional Healthcare, Inc. (ACH), as well as a letter giving Apple Developer Program Support permission to speak to Nikki Lund when setting up the new phone app.


Beverly Alden met with commissioners to discuss a road sign in Grant Township that has an incorrect address.

With no other business before the Commission, the meeting was adjourned at 12:00 p.m.




