CALDWELL COUNTY COMMISSION MEETING

1. CALL TO ORDER

Commissioner Akey called the meeting to order at 8:30 a.m.

2. ROLL CALL

Commissioners left a phone message for Mike Ryan with MOPERM to inquire about the status of the certificate of insurance required by Security Bank.
