CALDWELL COUNTY COMMISSION MEETING

Tuesday, July 09, 2024

1. CALL TO ORDER

Commissioner Akey called the meeting to order at 8:30 a.m.

Commissioners discussed an invoice for boiler maintenance. They called Waldinger's for clarification of the charges.

Commissioners discussed the need to replace the seal on the window of the county Ford Explorer. Commissioner Akey will see that the needed repairs get done.

Auditors Eric Kratzberg and Dalinuel Howard with McBride, Lock, & Associates met with commissioners to talk about the 2022 and 2023 audit for the county that they are currently conducting.

Terry Rumery met with commissioners to discuss Economic Development in the county.

Lisa Colson and Rebecca TenHulzen met with commissioners to discuss a possible CDBG grant for the Hamilton Senior Center. They also discussed the Broadband Breakthrough program and the need to name a team of citizens from the county to participate in Zoom meetings to learn more about the project.


Commissioners called elevator inspector, Daniel with ECI to inquire about the status of the elevator variance that was submitted by the county.


ADJOURNMENT
