Proposition B.E.S.T.

Shall the Board of Education of the Cameron R-1 School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Eight Million Dollars (\$8,000,000) for the purpose of providing funds to replace the Parkview Elementary roof; to construct, equip, furnish, and renovate High School classrooms; to demolish the current South wing of the High School building; to construct, equip, and furnish a maintenance shed/facility; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.9900 per one hundred dollars of assessed valuation of real and personal property.
