Commissioners received a call from Josh Green concerning a Planning & Zoning question about septic systems.


Commissioners met with Sheriff Mitch Allen to answer questions regarding the 2025 budget.



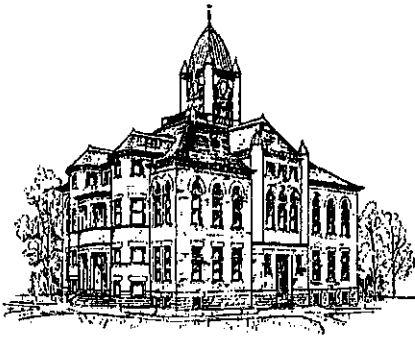

Commissioners met to discuss the 2025 budget.


Dana Brown met with commissioners to present the proposed 2025 Coroner's budget.


